An arbitration procedure is provided for in the FEI Statutes and General Regulations referred to above, in accordance with this procedure, any appeal against a decision rendered by the FEI or its official bodies is to be settled exclusively by the Court of Arbitration for Sport (CAS) in Lausanne, Switzerland.

2IV. Specific Technical Conditions (INDOOR)

1. Place: The event will take place in the : PHILIPSHALLE Düsseldorf, Siegburger Str. 15, D-40591 Düsseldorf.
2. Arena Dressage: 20 m x 60 m Type ground: sand
3. Practise Arena: approx. 20 m x 40 m Type ground: sand
4. Stables: in tents (sizes min. 9 sqm)

0V. Invitations

The foreign competitors will be invited by the organizer through their home NF.

PREAMBLE 4

- 1.) Foreign competitors, whose NFs receive an invitation (acc. Art. 484.2 per NF 2 riders)

Acc. Art. 484.2 of the World Cup Rules the following riders are invited:

- a) the first 10 riders of the FEI World Cup Standing List (per 03.04.2005).
- b) 6 nations, at least 12 riders including the first 10 of the FEI World Cup Standing List (per 03.04.2005).

If more than 2 riders from any particular nation are amongst the top 10, they will all be invited.

Invited nations: AUT, ESP, GBR, NED, RUS, SWE

- c) 1 rider who is nominated by the FEI.

- 2.) A maximum of 7 German riders, who are nominated by the national trainer dressage. In case less than 7 riders are invited, an additional nation will be invited to complete the number of starting places.
- 3.) 2 competitors with personal invitation from the Organizing Committee (Wild Card from the Organizing Committee)

Classes 10-11: Each rider can take part with one horse of 7 years and older.

THE ORGANIZING COMMITTEE DRAWS UP A "MASTERLIST" OF THE DEFINITE ENTRIES, CLASSIFIED ACCORDING TO THE ABOVE CRITERIA, WHICH MUST BE GIVEN TO THE GERMAN NF OFFICE, THE FOREIGN JUDGE AND THE NF DELEGATE ON THE MONDAY PRECEDING THE EVENT. CHANGES ARE ONLY POSSIBLE PRIOR TO THE BEGINNING OF THE EVENT AND ONLY BY MUTUAL CONSENT.

VI. FACILITIES OFFERED

A. Riders

Hotel reservation/Meals

For the foreign and German riders of the CDI-W per rider one single room will be booked only on order in the riders' hotel from 31 March – 02 April 2005. Acc. to the rules of the FEI World Cup Dressage Events the Organizing Committee bears the costs.



Extras such as beverages, food, phone, parking taxes, etc. are on account of the competitor. In case of an earlier arrival, in case a double-room (on own account) or additional rooms (on own account) are required, the Organizing Committee must be informed by the 21.03.2005 the latest. If non-used hotel rooms are not cancelled by the 21.03.2005 the latest, the Organizing Committee charges them to the riders account.

Riders' Hotel: Lindner Hotel Rheinstern

Hotel accommodation for competitors must be booked with the nominated entry. The Organizing Committee cannot ensure hotel bookings that are not made as described above, i. e. incoming by phone or after closing date of entries.

Meals for the CDI-W competitors are provided as follows: From 31.03. (noon) – till 02.04 (noon) in the V.I.P. room/riders'/grooms' catering area.

Breakfast will be served in the hotel!

B. Grooms

Riders have to book accommodation for their grooms themselves on their own account.

All grooms (1 groom per rider) of CDI-W-Final horses competing in the international competitions will receive meal vouchers from 31. March 2005 (morning) to 02. April 2005 (noon).

Sufficient sanitary and showering facilities for male and female grooms, with hot and cold water, will be provided by the Organizing Committee.

Lorries and trailers with sleeper-cab will be parked near the stables, provided there will be enough space. If it is technically possible, the stable manager will provide electricity. (no self service)

For electricity (including electricity for caravans and lorries) a one-time fee of € 50,- incl. VAT will be charged - payable when settling the accounts. Please take care of sufficient long cable yourself.

It is strictly forbidden to shunt electricity from the stables.

C. Horses

Box arrangement international

Stabling will be available for the participating horses of riders according to preamble 4 from 30 March 2005 (evening) (only on application in advance) to 03.04.2005 in tents at the Düsseldorfer PHILIPSHALLE.

First Bedding (with wood-shaving) for all horses will be at the account of the Organizing Committee, who will arrange its distribution via the stable manager.

Box reservations have to be made on submission of the entry form.

If no box reservation has been made by 21.03.2005 by the home NF or the rider, then the Organizing Committee will reserve and invoice as many boxes as the definite entry indicates.

Only boxes which have been assigned by the stable manager beforehand may be used.

Reservation of additional tack boxes is only possible on prior application and depends on availability.

Bedding

Hay, straw and wood-shavings can be bought on immediate payment to the stable manager at the daily rate.

Cost of Straw, Hay and Shavings : Straw = € 4,-; Hay = € 5,- and Shavings = € 6,-

Feed : Feed/Feed-bucket/hay net have to be brought along with the horses.

It is strictly forbidden to smoke in the stable-area!

D. Arrival

Date, time of riders and horses and their means of transportation have to be given to the Organizing Committee to facilitate them on arrival.

E. Shuttle-Service

Local transportation arrangements from hotel to show grounds will be made available. Request for shuttle at the Shuttle Service at the VIP-desk next to the main entrance.



E. Advertising

The competitors are authorised to carry the logo of their personal sponsor on the saddle cloth in accordance with Art. 136.

The Chief Steward is responsible for ensuring that FEI Regulations relating to Art. 136 are respected by riders before entering the arena. Competitors not complying with Art. 136 will not be permitted to enter the arena during the competition.

H. Additional Costs

All additional costs such as veterinary expenses, additional carriage and transport costs are borne by the horses' owner.

Entry-forms must include the following information on horses: name of the horse, date of birth, breed, country of birth, studbook initials, passport number, name(s) of owner(s), colour, and sex.

Foreign competitors have to be entered by their responsible NF.

Entry Fee per CDI-W horse: € 200,- / horse

(including stable and a fee of € 1,- per reserved starting place - contribution to the regional association of Rhineland)

(Acc. to the FEI World Cup rules maximum costs for the CDI-W riders are € 300,-- including all taxes such as entry fee, electricity costs, border documents, MCP)

In addition the MCP fee of € 8,50 per horse (equivalent of CHF 12,50) have to be paid at closing time of declarations. (FEI rule).

2.) Vet. Aspects A according to Vet. Regs./9th edition 2002

Veterinary Examinations, Horse Inspections and Passport-Controls.

These will be carried out in accordance with the Veterinary Regulations of the FEI, article 1011 and the FEI Rules for Jumping Events, Annex VII, and the Dressage Rules Annex I, as well as the General Regulations 20th edition, revision 2001.

In accordance with Art. 139.1 :

Every horse entered for any competition at CNs, CDIs1/2*, CDIYJPs, CSIs1* and CSIJYPChVS Cat. B in a foreign country, and all horses entered for CDIs3*, CSIs2/3/4/5* and CSI J.Y.Ch.V.Ps Cat. A, CIOs, Championships, Regional and Olympic Games, whether at home or in foreign countries, must have an official and valid FEI Passport, or a National valid Passport approved by the FEI and accompanied by a FEI Recognition Card, as a means of identification and to establish ownership.

In accordance with Art. 139.2 :

Horses taking part in CNs, CDIs1/2*, CDIYJPs, CSIs1* and CSI JYPChVs. Cat. B in their own country are not required to have such a passport as is mentioned in paragraph 1. All such horses must be properly registered and identifiable by diagram. Unless there is no national requirement for equine influenza vaccination in the host country and in the country of origin, all horses must have a valid vaccination certificate.

Horse Inspection (please take updated times in the schedule into consideration!)

CDI-W horses: Thursday, 31.03.2005, 15.00 – 16.00 hrs. near the stables

Vaccination against Equine Influenza (Veterinary Regulation Appendix VI).

All horses for whom a FEI-Passport, or a National Passport approved by the FEI, has been issued, must have the vaccination section endorsed by a Veterinary Surgeon, who is not the owner of the animal, stating, that it has received two injections for primary vaccination against Equine influenza, given no less than 21 days and no more than 92 days apart. In addition, a booster-injection must be recorded as having been given within each succeeding 6 months, subsequent to the second injection of the primary vaccination. None of these injections must have been given within the preceding seven days, including the day of the first competition or the entry into the competition stables. The above are the minimum requirements for influenza vaccination.

Both primary and first subsequent booster injections should be given according to the manufacturer's instructions which will fall within the stipulation of the FEI ruling. In many cases booster injections are recommended by the manufacturers and National Veterinary Authorities/Regularity Authorities at intervals more frequent than 12 months.

Horses, whose vaccination against equine influenza does not match with the valid regulations will not be permitted to enter the show stables.

Sampling for prohibited substances, Vet. Regs. Chap. V & VI and App. III.

Regular sampling is carried out in CCI3/4*, CSIs3/4/5*, CDI3*, CIOs, World Cup Qualifiers and Finals, Championships and Games, whereas at other CIs sampling is recommended. Special guidelines are applicable for events covered by the FEI Medication Control Programme (Groups I & II only).

Medication Control Program (MCP)

The Organising Committees of FEI events within Groups I & II are advised to charge competitors € 8,50 (the equivalent of CHF 12.50) per horse per event as a contribution towards the costs of the MCP programme.

Approved Laboratory (Art. 1022)

Under the Medication Control Program (MCP) in Groups I and II (Western Europe), all samples collected in accordance with VR Art., 1017.1, will be analysed by the Laboratoire Courses Hippiques, 15 rue de Paradis, 91370 Verrières le Buisson, France, Tel.: +33.1 - 69 75 28 28, Fax: +33.1 - 69 75 28 29.

Health-Certificate

At the time of the first horse examination, i.e. on arrival of the horses on the show venue and before entering the stables, every competitor is obliged to have on hand the health certificates which are required for the transport to the event;

- a.) if the competitor comes from an EU member country, a health certificate for registered equidae according to the specimen of annex B of the directive 90/426 EEC in the currently valid issue (see attached specimen)
- b.) if the competitor comes from a third country, a health certificate for registered equidae according to the specimen of annex II of the decision of the Commission 92/260 in the currently valid issue.



A certificate must be done in at least one official language of the country of destination and in one official language of the member country. The competitor must carry with him the original certificate, not a copy.

The organiser sees to it that on the competition site, an official state veterinarian is present to issue the health certificates which are necessary for the transport of the horses to their destination abroad.

In case the OC has entrusted to a forwarding agency, the latter is ready to assist regarding the required documents. Besides, questions relating to health requirements for horses can be directed to the veterinary authorities in the country of origin or in Germany.

X. MISCELLANEOUS

1. Objections/Complaints

All objections/complaints must be made in writing and be delivered personally to the President of the Ground Jury or the President of the Appeal Committee respectively of the event. Each objection/complaint must be accompanied by the deposit of € 90,--(FEI RG Art. 167-171). Equivalent CHF 150,--.

2. Payment of prize-money or prizes in kind and indemnities

All prize money and all prizes in kind rewarded instead of prize money as well as reimbursements (e. g. transport charges, travelling expenses) will be distributed acc. to FEI-RG Art. 130.2 following the last competition at the latest. The scheduled prizes are gross amounts. If riders have to be placed equally, the money value of the prizes in kind (e. g. a car) is divided accordingly. Settlement will be done per competitor. Depending on the agreement with the horse owner, each competitor binds himself, to pass on to the horse owners the prize money or prizes in kind rewarded instead of prize money. The organizer is allowed to deduct possibly outstanding debts of the competitor. Acc. to § 50a Abs. 4 this also applies to foreign horse owners. After having deducted the turnover tax from the prize money or prizes in kind rewarded instead of prize money the following income tax will be due: no taxes up to 250 EUR, 10 % up to 500 EUR, 15 % up to 1,000 EUR, 20 % exceeding 1,000 EUR; plus 5,5 % solidarity fee of the income tax. The tax deduction has to be confirmed on demand. Those foreign competitors being exempted from tax deduction are kindly asked to submit an exemption certificate either with the entry or on the first show day at the latest. Every competitor himself is responsible for the correctness of the details he submits.

3. Insurances

All owners and competitors are personally responsible for damages to third parties caused by themselves, their employees, their agents of their horses. They are therefore strongly advised to take out third-party insurance providing full coverage for participants in equestrian events at home and abroad, and to keep the policy up to date.

4. Liability

The organiser expressly declines any liability for property or pecuniary damage which may happen to owners, riders, grooms, spectators or horses through slight negligence of the organizer, his delegates or his assistants. He also declines any liability for theft, damages, fire, or any other incidents.

5. Event's Organization

In exceptional circumstances, together with the approval of the riders, Ground Jury and the NF Delegate, the OC reserves the right to modify the schedule in order to clarify any matters arising from an omission or due to unforeseen circumstances. Any such changes must be notified to all competitors and officials as soon as possible and they must be reported to the FEI-Sec.Gen. by the foreign Judge.

6. Entry Rights to the Showground

Entry accreditations will be given free of charge to the competitors (1), their partners (1) and their grooms (1 per rider). An owner of a horse (who is not a competitor and whose name is mentioned in the FEI passport of the concerned horse), will receive one entry accreditation. Maximum 2 owners per horse.

Entry right to the stables are according FEI VR Art. 1005.2.5

7. Declaration of starters

Declarations for the first competition of a day have to be done the evening before at the Secretary's Office by 18 hrs. All other declarations have to be made 60 minutes before the start of the concerned class at the latest.

8. Veterinarian, Doctor

A veterinary surgeon, farrier and doctor will be available to the competitors, on their own account.



9. Acceptance of this Schedule

All persons involved (rider, owner, groom, trainer, etc.) accept this Schedule when handing in the entry of their horse.

10. Pictures

The Organizing Committee has the right to use photographs and video-tapes of riders and horses, made during the Düsseldorf Masters show 2005, for promotional purposes.

CODE OF CONDUCT

The Federation Equestre International (FEI) expects all those involved in international equestrian sport to adhere to the FEI's Code of Conduct and to acknowledge and accept that at all times the welfare of the horse must be paramount and must never be subordinated to competitive or commercial influences.

1. At all stages during the preparation and training of competition horses, welfare must take precedence over all other demands. This includes good horse management, training methods, farriery and tack, and transportation.
2. Horses and competitors must be fit, competent and in good health before they are allowed to compete. This encompasses medication use, surgical procedures that threaten welfare or safety, pregnancy in mares and the misuse of aids.
3. Events must not prejudice horse welfare. This involves paying careful attention to the competition areas, ground surfaces, weather conditions, stabling, site safety and fitness of the horse for onward travel after the event.
4. Every effort must be made to ensure that horses receive proper attention after they have competed and that they are treated humanely when their competition careers are over. This covers proper veterinary care, competition injuries, euthanasia and retirement.
5. The FEI urges all involved with the sport to attain the highest levels of education in their areas of expertise.
