## B) Grooms

Grooms (one per rider) : hotel and meals at their own expense. Sufficient sanitary and showering facilities for male and female grooms, with hot and cold water will be provided by the Organising Committee.

## C) Horses

The stables will be ready from Wednesday August 2<sup>nd</sup>, 5 PM to Monday August 7<sup>th</sup>, 12.00 noon.

The booking of the boxes is included in the entries

120 solid boxes (3x3) reserved in priority to stallions and in the order of reception of the reservations, on a first come first served.

130 temporary boxes (3x3)

**Reservations must be made at the same time as the entries.**

The boxes will be furnished with straw . The stables will be only to authorised persons open (Riders, one groom per rider, owners )

**Straw : provided free of charge from 8 to 9.30 AM only**

**Riders willing shaving in their boxes (at their own expense) must inform the Organising Committee with the definite entries.**

Horse feeding is at the participants' expense.

Possibility of buying shavings (10€ the pack), hay (5 € the truss), granules of "Royal Horse" (15 € for 25 kg), daily **between 8 to 9.30 AM and 5 to 6 PM.**

For any cancellation which will not be notified before July 31<sup>st</sup> 12 o'clock, the riders will be charged 90 € per horse.

Horses can be accepted the previous week and the week after: 30 € per horse and night, as well as for any refused horse or any extra horse.

## D) Welcome

**With definite entries**, the date and time of arrival of riders and horses and their means of transport must be given to the OC in order to facilitate them on arrival. The owners, the riders and the grooms must declare their names and functions to the secretary at the date of definite entries.

**With definite entries**, the date and time of departure of riders and horses must be given to the OC in order to organise the stables for the young horses event which begins on **August the 7<sup>th</sup>** .

### ***VETERINARY EXAMINATIONS, HORSE INSPECTIONS & PASSPORT CONTROLS***

This inspection will be broadly open to the public, with commentator and will be sponsored by one of our sponsors. Grooms and riders are kindly asked to take a particular care to their own dresses and to the look of the horses which must be presented with snaffles.

**Veterinary inspection will take care on Tuesday August 3<sup>rd</sup>**

**from 11 AM to 2 PM for six and seven years old horses**

**and from 11AM to 6 PM for horses of the CSI\*\***

Horses which will not be presented at this inspection will be seen:

**Six and seven years old horses : after 2 PM  
BUT WILL NOT BE ALLOWED TO COMPETE IN COMPETITION 1 AND 2.**

**CSI\*\* horses : Friday between 9 and 9.30 AM  
BUT WILL NOT BE ALLOWED TO COMPETE IN COMPETITION 3 .**

## **VETERINARY ASPECTS "A"**

### ***VETERINARY EXAMINATIONS, HORSE INSPECTIONS & PASSPORT CONTROLS***

These will be carried out in accordance with the Veterinary Regulations, Art. 1011, 10<sup>th</sup> Edition, 1<sup>st</sup> January 2006 .

**"General Regulations", 21<sup>st</sup> Edition, 1<sup>st</sup> January 2006 will apply:**

#### **Art. 139.1**

Every horse/pony entered for any competition at CSNs or CIM (see appendix D) in a foreign country, and all horses/ponies entered for other CSI\*\*/\*\*/\*\*\*\*/\*\*\*\*\* , CSIOs, Championships, Regional and Olympic Games, whether at home or in foreign countries, must have an official, valid FEI Passport, or a National Passport approved by the FEI accompanied by an FEI Recognition Card, as a means of identification and to establish ownership.

#### **Art. 139.2**

Horses/ponies taking part in CSNs or CIM (see appendix D) in their own country are not required to have such a passport as mentioned in paragraph 1. All such horses/ponies must be properly registered and identifiable by diagram. Unless there is no national requirement for equine influenza vaccination in the host country and in the country of origin all horses/ponies must have a valid vaccination certificate.

**EQUINE INFLUENZA VACCINATION, VET. REGS. APPENDIX VI** (except events taking place in NZL & AUS)

All horses and ponies for which an FEI Passport, or a National Passport approved by the FEI has been issued, must have the vaccination section endorsed by a veterinarian, stating that it has received two injections for primary vaccination against equine influenza, given no less than 21 days and no more than 92 days apart.

In addition, a booster injection must be recorded as having been given within each succeeding 6 months, subsequent to the second injection of the primary vaccination. None of these injections must have been given within the preceding 7 days including the day of the competition or of entry into the competition stables.

The above are the minimum requirements for influenza vaccination. Both primary and first and subsequent booster injections should be given according to the manufacturer's instructions, which will fall within the stipulation of the FEI ruling.

**SAMPLING FOR PROHIBITED SUBSTANCES (Vet. Regs. Chapter V & VI and Annex III)**

Regular sampling is carried out in CCI<sup>\*\*\*</sup>/<sup>\*\*\*\*</sup>, CSI<sup>\*\*\*</sup>/<sup>\*\*\*\*</sup>/<sup>\*\*\*\*\*</sup>, CIOs, World Cup Qualifiers and Finals, Championships and Games, whereas at other CIs sampling is recommended. In CICs<sup>\*\*\*</sup>/<sup>\*\*\*\*</sup>, the number of horses tested is at the discretion of the Testing Veterinarian/Veterinary Delegate; however, a minimum of three is recommended (Art. VR 1016)

Special guidelines are applicable for events covered by the FEI Medication Control Programme (Groups I & II only).

**MEDICATION CONTROL PROGRAMME (GROUP I & II ONLY)**

The Organising Committees of FEI events within Groups I & II are advised to charge competitors the equivalent of CHF 12.50 per horse/pony per event as a contribution towards the costs of the MCP programme.

**A) HEALTH REQUIREMENTS FOR THE ENTRY OF HORSES/PONIES**

**B) CUSTOMS FORMALITIES**

NFs holding an international event in their country should inform their national veterinary authority and their customs authority at least four weeks prior to the event. They should request every facility to assist the movement of horses/ponies accompanied by FEI passports and the necessary veterinary certification at frontier crossing points into and out of their countries. (Vet. Regs. Art. 1004.2).

## VIII MISCELLANEOUS

### 1) OBJECTIONS/COMPLAINTS - (Art. 167 & 171)

All complaints and objections to be valid must be made in writing and accompanied by a deposit of CHF 150.- or equivalent.

### 2) ENTRIES

The entries must be down every day **before 6 pm for the day after**

### 3) PRIZE-GIVING CEREMONY (Art 128, 129, 130)

***Please note the precise dispositions for each Prize Giving Ceremony :***

The first eight riders of each class must be present for the prize giving ceremony;  
For the first three riders, their horses will be led by their grooms and will enter the arena behind the Chief Steward. The riders will walk to the Honor place, the other riders will come on their horses;

After the national anthem, they will be congratulated by the officials and the sponsors. Afterwards, all the eight riders will go around for the lap of honor.

The owners of the first three horses will be invited to the prize giving ceremony. After the ceremony, the first three riders must go to the sponsor's box to salute him and his guests.

### 4) DISTRIBUTION OF PRIZES AND INDEMNITIES - (Art. 130)

For foreign riders, all payments will be due to France law and tax regulations (15%). All prize money will be distributed following the last competition at the latest.

### 5) DOCTOR, VETERINARIAN, FARRIER (Art RG 114.9)

The CO will not intervene in matters concerning payment of any medical, veterinary or farrier matter.

### 6) INSURANCES

"All owners and competitors are personally responsible for damages to third persons caused by themselves, their employees, their agents or their horses/ponies. They are therefore strongly advised to take out third-party insurance providing full coverage for participation in equestrian events at home and abroad, and to keep the policy up to date."

### 7) INTERNATIONAL NUMBERS

The international numbers will be distributed with a caution of 5 euro at the General Secretary before Veterinary Inspection.

**8) EVENT'S ORGANISATION - (Art. 114,115)**

In exceptional circumstances, together with the approval of Chefs d'Equipe and Ground Jury the OC reserves the right to modify the schedule in order to clarify any matters or matters arising from an omission or due to unforeseen circumstances. Any such changes must be notified to all competitors and officials as soon as possible and they must be reported to the Secretary General by the Foreign Judge.

**9) ENTRY RIGHT TO SHOWGROUNDS (Art. 133, 1005)**

The OC will issue each competitor a maximum of 2 bracelets for entry into the FEI stables and each groom with one bracelet. Registered owners of competing horses may receive a maximum of 2 bracelets per horse.

**10) SCHOOLING DURING COMPETITIONS**

Riders wishing to school during speed competitions must inform the OC before these competitions begin. These riders will start first in these competitions.

**11) SCHOOLING BETWEEN COMPETITIONS**

The times when the training areas will be open will be indicated on the official board and will be placed under the responsibility of an official steward.

**12) SAFETY CUPS**

FEI safety cup : CARO (Germany).

**13) START LISTS & RESULT SHEETS**

The name of the owner of each horse/pony will be added to all start lists and result sheets.

**14) DISPUTES**

In the event of any discussion concerning the interpretation of the schedule (in translated languages), the French version will be decisive.

**15) GROOMS**

It is appreciated that grooms wish to remain with their horses/ponies during the night. Only grooms duly registered with the OC are permitted to do so.

**16) MOVEMENT THROUGHOUT EVENT GROUNDS**

The horses must wear their numbers for any movement between the stables, training arenas and main arena.

**17) CONTROL OF BANDAGES AND BOOTS**

The Jumping Committee makes it obligatory for bandages and boots to be removed from each horse after his participation in Grand Prix competitions, Derby and each round of the nations Cup competition.

This inspection will be carried by the Chief Steward who can be assisted by the FEI veterinary or the treating veterinary.

**18) INSPECTION OF THE COURSES**

**When inspecting the course, competitors are requested to wear their dress of competition and may be accompanied by their coach**

# THE FEI CODE OF CONDUCT

## FOR

### THE WELFARE OF THE HORSE

The Fédération Equestre Internationale (FEI) expects all those involved in international equestrian sport to adhere to the FEI's Code of Conduct and to acknowledge and accept that at all times the welfare of the horse must be paramount and must never be subordinated to competitive or commercial influences.

1. At all stages during the preparation and training of competition horses, welfare must take precedence over all other demands. This includes good horse management, training methods, farriery and tack, and transportation.
2. Horses and competitors must be fit, competent and in good health before they are allowed to compete. This encompasses medication use, surgical procedures that threaten welfare or safety, pregnancy in mares and the misuse of aids.
3. Events must not prejudice horse welfare. This involves paying careful attention to the competition areas, ground surfaces, weather conditions, stabling, site safety and fitness of the horse for onward travel after the event.
4. Every effort must be made to ensure that horses receive proper attention after they have competed and that they are treated humanely when their competition careers are over. This covers proper veterinary care, competition injuries, euthanasia and retirement.
5. The FEI urges all involved with the sport to attain the highest levels of education in their areas of expertise.
