## AQHA European Experience

### - Special Conditions -

Eligible for the AQHA classes are American Quarter Horses, horses of other breeds may take part at the clinics and the trail ride. If an exhibitor placed in the top two(2) in any AQHA class at the 2009 European Championship finals, such exhibitor shall be ineligible to compete in the same class at the Experience. Such exhibitor however is eligible to compete in any other class. If a horse placed in the top two(2) in any halter class at the 2009 European Championship finals, such horse shall be ineligible to compete in any halter class at the Experience. If an exhibitor placed in the top two (2) in any halter class at the 2009 European Championship finals, such exhibitor shall be ineligible to compete in any halter class with a horse of the same sex. Permits for Novice Amateur and Novice Youth showing a non-family member owned horse are accepted at the Experience.

In each class (Open, Amateur, Novice Amateur, Youth or Novice Youth) winners can look forward to prizes such as:

1. Place : Montana Silversmith Buckle
2. Place : Professional's Choice Saddle Pad (for Performance Classes, horse boots for Halter)
3. Place : WeatherBeeta horse cover
4. Place : Farnam Gift Box
5. Place : American Quarter Horse Journal hay bag
6. Place : Gift QHAL

For All-Around Champions (Amateur, Novice Amateur, Youth or Novice Youth): a Nobleman Saddle by Tex Tan

Show Bill according to the AQHA Rule Book 2010:  
Equipment/bits set forth in the current AQHA Rule Book.  
Parts of the European Experience are clinics and a trail ride. Participants can take part in these activities even if they are not entered for the show. Clinics and trail ride are open for all breeds. Clinics are free for members of the AQHA/QHAL. For all clinic only a specific contingent is available. Places will be allocated in order of registration.

- K1 – Reining
- K2 – Cutting
- K3 – Horsemanship
- K4 – Trail
- K5 – Halter/Showmanship
- K6 – Western Pleasure

### General Show Terms:

The terms for the show are governed by the rules and regulations set forth in the current official handbook of the AQHA, NRHA, NCHA, NSBA, FEI

1. Entries will only be accepted when
  - The entry form is received completely filled out and in a timely manner.
  - The entry fee and box rental fee is paid in full and the participant has a valid membership. A copy of the 2010 membership card must be attached to the entry form. Memberships can be acquired at the show.
  - The copy of the registration paper or license are recieved with the entry form.
2. The exhibitors/horse owner acknowledges this show bill as well as the terms of the event when sending the entry form.
3. The organizer reserves the right to change the show bill prior to the entry deadline, to reschedule the event or to cancel the event by returning payments made when necessitated by special circumstances.
4. There is no contractual relationship between the organizer and the visitors, horse owners and exhibitors. Any joint liability for theft and injury on humans and animals is excluded. Exhibitors are no assistants as set forth in §278 and §831 German civil Code. Every horse owner and exhibitor when submitting the entry form subjects himself to the instructions and directions of the organizer and the show director and accepts the rules of the AQHA and the NRHA, NCHA, NSBA as well as the FLSE/FEI. So does every companion and visitor when entering the site.
5. The organizer is not responsible for any mail lost.
6. Each horse must be covered by liability insurance. The horses must be free from contagious disease resp. come from a stable where contagious disease is unknown. All horses participating at the show must be immunized at the time of the show especially immunized against influenza. The horse owners must be able to proof immunization by presenting the vaccination record to the show office on request.
7. On presentation of a medical record prior to show start the show management can refund half of the entry fee. Cattle and office charge will not be refunded. Box fees will only be reimbursed when the reserved box can be re-rented.

### Special Conditions CRI

All exhibitors must present their entry to their national equestrian association! Exhibitors may only take part in this class when the registration came from the respective national equestrian association. A registration which was sent to the organizer only is not sufficient. Basically all horses must be registered with the FEI. Alien horses must have a FEI passport, domestic horses a FEI-or Equidenpass. Vaccinations must be recorded in the FEI-/Equidenpass, a record in a separate vaccination pass is not sufficient.

### Doping

1. By signing the entry form the exhibitor resp. horse owner agrees to a horse doping test by urine analysis or blood test.
2. § 441 AQHA Rule Book 2010, the doping rules of the FN, apply accordingly as to where no foreign substances are allowed.
3. In case of positive test results the exhibitor resp. horse owner has to bear the costs.
4. The respective horse/exhibitor combination will be disqualified retroactive and has to return all cash and non-cash prizes and all rankings.
5. In addition the organizer reserves the right of further disciplinary actions/sanctions against the particular horse/exhibitor combination or horse owner.

### Payment of cash prizes and reimbursement

The exhibitors will be awarded cash and non-cash prizes only if they appear to the award ceremony in official show outfit. Depending on agreement between horse owner and exhibitor the participant comits himself to pass on cash and non-cash prizes to the horse owner. The organizer is authorized to deduct any outstanding balance owed by the participant.
