### 2. Competition Arena

Competition Area 60 x 20 m, sand, outdoor  
Practice arenas 80 x 20 m, sand, indoor

During the competition two competitors have to be ready to enter the competition arena. If a competitor does not react upon calling his starting number, his turn will pass and he will be eliminated from that competition (unless certain circumstances prevent e.g. losing a horse-shoe before his turn to start).

### b) Grooms

Sufficient sanitary and showering facilities will be provided near to the stable area by the O.C..  
Meals: Breakfast and lunch possibilities (at their own expense).

**c) *Stabling - Ponies/Horses***

Horses, ponies participating in the competition must be stabled on the showgrounds. Reservation of the boxes must be made in conjunction with the definite entries. The stables will be open from Wednesday 2 July 2003 at 9.00 am. The first bedding will be provided. Straw and shavings will be available.

Extra bedding will be available at current prices.

**3. Veterinary Aspects "A" :** According to the Veterinary Regulations 9<sup>th</sup> edition 2002

#### **Veterinary Examinations, Horse inspections and Passport controls:**

These will be carried out in accordance with Vet. Regs. Art 1011; Rules for Dressage Events Annex 1.

General Regulations 20<sup>th</sup> edition, effective 1<sup>st</sup> January 2000, will apply:

*in accordance with Art 139.1.*

Every horse entered for any competition at CDNs, CDIs\*, CDIs\*\*, CDI/J-Y-Ps, in a foreign country, and all horses entered for CDIs\*\*\*, Championships, Regional and Olympic Games, whether at home or in foreign countries, must have an official valid FEI passport, or a National passport approved by the FEI accompanied by an FEI Recognition Card, as a means of identification and to establish ownership.

*in accordance with Art 139.2*

Horses taking part in CDNs, CDIs\*, CDIs\*\*, CDI/J-Y-Ps in their own country are not required to have such a passport as is mentioned in paragraph 1. All such horses must be properly registered and identifiable by diagram, and unless there is no national requirement for equine influenza vaccination in the host country and in the country of origin, all horses must have a valid vaccination certificate.

#### **Equine influenza vaccination Vet. Regs. Annex VI:**

All horses and ponies for which an FEI passport or a National passport approved by the FEI has been issued must have the vaccination section endorsed by a veterinarian who is not the owner of the animal, stating that it has received two injections for primary vaccination against equine influenza, given no less than 21 days and no more than 92 days apart. In addition, a booster injection must be recorded as having been given within each succeeding 12 months subsequent to the second injection of the primary vaccination. None of these injections must have been given within the preceding 7 days including the day of the competition or of entry into the competition stables.

The above are the minimum requirements for influenza vaccination. Both primary and first and subsequent booster injections should be given to the manufacturer's instructions, which will fall within the stipulation of the FEI ruling. In many cases booster injections are recommended by the manufacturers and by National Veterinary Authorities/Regulatory Authorities at intervals more frequent than 12 months.

#### **Sampling for prohibited substances, Vet. Regs Chap V & VI and Annex III**

Regular sampling is carried out in CDIOs\*\*, CDIOs\*\*\*, World Cup Qualifiers, Cup Finals, Championships and Games, whereas at other CDIs sampling is recommended.

Special guidelines are applicable for events covered by the FEI's Medication Control Programme (Group I and II only).

#### **Medication control program (Group I & II only):**

The Organising Committee of FEI events within Groups I & II are advised to charge competitors the equivalent of CHF 12,50 per horse per event as a contribution towards the cost of the MCP programme.

### **4. Veterinary Aspects "B"**

#### **Customs Formalities**

Health requirements for the entry of horses:

For ponies/horses coming from abroad a health certificate stating that they are free from contagious diseases must be presented.

Agent and veterinary fees of entering and leaving Luxembourg will be paid by the O.C. for foreign ponies/horses competing in the CDI.

Non EC competitors are strongly advised to travel with an ATA carnet. There is no travel agency in charge.

**Attention: The request for sanitary documents has to be made at the secretary's office at arrival, or before Friday 4 July, 9 am.**

#### **Approved laboratory:**

Under the Medication Control Program (MCP9 in Groups I & II (Western Europe) all samples collected in accordance with VR Art 1017.1 will be analysed by the L.A.B. ## VII MISCELLANEOUS

### 1. Complaints/Objections (Art 167-171)

All complaints and objections to be valid must be made in writing and accompanied by a deposit of 150 CHF or equivalent.

### 2. Dogs - Motorcycles

Dogs must be on a leash during the whole event - motorcycles are not allowed in the competition area.

### 3. Distribution of Prizes

Prize giving will take place in the competition area at the end of each class. The placed riders and horses/ponies must be present.

All placed combinations (25 % - min 5) will receive valuable prizes, ribbons and stable plates.

The winner will receive a cup.

The O.C. must retain an income tax of 15 % from the amounts paid to foreign horse/pony owners and competitors.

### 4. Insurances

All owners and competitors are personally responsible for damages to third parties caused by themselves, their employees, their agents or their ponies/horses. They are therefore strongly advised to take out third-party insurance providing full coverage for participation in equestrian events at home and abroad, and to keep the policy up to date.

### 5. Responsibility of Chefs d'Equipe

The Chefs d'Equipe are responsible for the behaviour of their teams and/or individuals throughout the events. They and their NF are responsible for any damages that occur. The Chef d'Equipe must stay with their team(s) and/or individuals.

### 6. Event's Organisation (Art 115.1 and 2)

In exceptional circumstances, together with the approval of the Chefs d'Equipe and the Ground Jury, the O.C. reserves the right to modify the schedule in order to clarify any matter or matters arising from an omission or due to unforeseen circumstances. Any such changes must be notified to all competitors and officials as soon as possible, and the Foreign Judge must report them to the FEI Secretary General.

### 7. Entry Right to the showground

Entry to the showground will be in accordance with Art 133 and 1005 for Competitors, Chefs d'Equipe, Team Veterinarians, Grooms (two per team) and Owners (two per pony/horse). We will have special plastic-ribbons.

Access to stable area will be limited in accordance with Art 1005.2.5 of the Vet. Reg..

### 8. Veterinarian and Blacksmith

A veterinarian surgeon and a blacksmith will be available to the competitors at their own expense.

### 9. International Dressage Competitions for Ponies

Open to pony-riders acc. to Arts 3102 and 3103 with ponies of 6 years and over.

Dress and saddlery acc to Arts 3128 and 3129.

Judgment and classification acc. to Arts 430-434

### 10. International Dressage Competitions for Juniors

Open to junior-riders acc. to Art J2 with horses of years and over.

Dress and saddlery acc to Arts 427 and J17.

Judgment and classification acc. to Arts 430-434

### 11. International Dressage Competitions for Young Riders

Open to Young-riders acc. to Art YR2 with horses of years and over.

Dress and saddlery acc to Arts 427 and YR 7.4 Art 428.

Judgment and classification acc. to Arts 430-434

### 12. Final Conditions

Once the entry has been made, all riders and owners accept the rules of the JIL 2000, as well the conditions of the O.C..

## VIII WELFARE OF THE HORSE

### Code of conduct

1. In all equestrian sports the horse must be considered paramount.
2. The well being of the horse shall be above the demands of breeders, trainers, riders, owners, dealers, organisers, sponsors or officials.
3. All handling and veterinary treatment must ensure the health and welfare of the horse.
4. The highest standards of nutrition, health, sanitation and safety shall be encouraged and maintained at all times.
5. Adequate provision must be made for ventilation, feeding, watering and maintaining a healthy environment during transportation.
6. Emphasis should be placed on increasing education in training and equestrian practices and on promoting scientific studies in equine health.
7. In the interests of the horse, the fitness and competence of the rider shall be regarded as essential.
8. All riding and training methods must take account of the horse as a living entity and must not include any technique considered by the FEI to be abusive.
9. National Federations should establish adequate controls in order that all persons and bodies under their jurisdiction respect the welfare of the horse.
10. The national and international Rules and Regulations in equestrian sport regarding the health and welfare of the horse must be adhered to not only during national and international events, but also in training. Competition Rules and Regulations reviewed to ensure such welfare.
